4 - FIRST AID MEASURES

6 - ACCIDENTAL RELEASE MEASURES

Personal precautions:

Methods for cleaning up:

If a large amount has been spilt, evacuate all personnel and only allow intervention by trained operators equipped with safety apparatus.
Clean preferably with a detergent, do not use solvents.
